# Temporary and Disability Assistance Statistics

## **NOVEMBER 2005**

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 597,888 in November 2005, decreasing by 4,870 (-0.8%) from the previous month. Related expenditures totaled \$154,628,664 in November 2005 increasing by approximately \$3.7 million (+2.4%) over October 2005.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,777,238 in November 2005, increasing by 13,570 (+0.8%) over October 2005. Food Stamps expenditures totaled \$188,104,379 in November 2005, increasing approximately \$1 million (+0.6%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For November 2005, SSI recipients (including Mental Hygiene) totaled 640,718 increasing 4,176 (+0.7%) from the previous month. SSI expenditures in November totaled \$315,732,285 increasing approximately \$9.6 million (+3.1%) from October 2005.

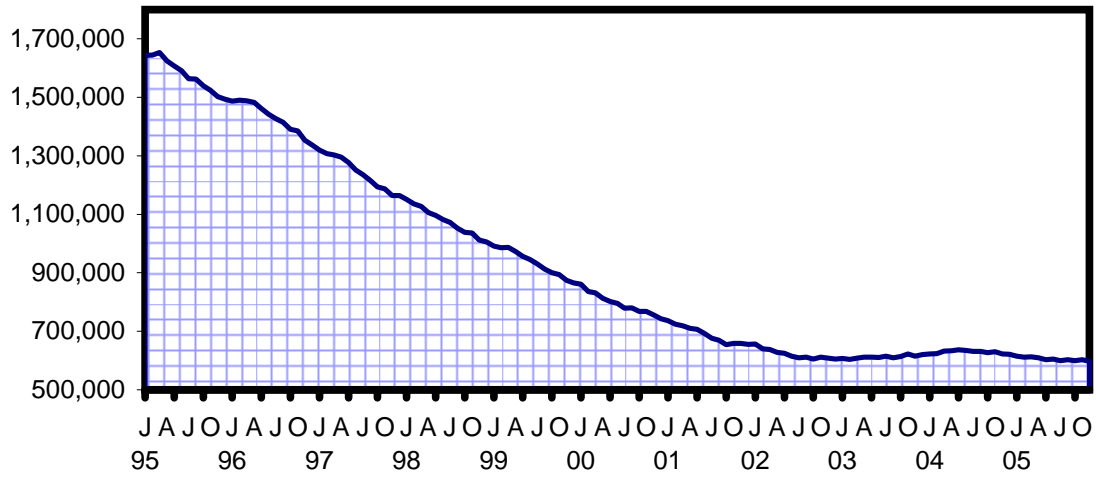

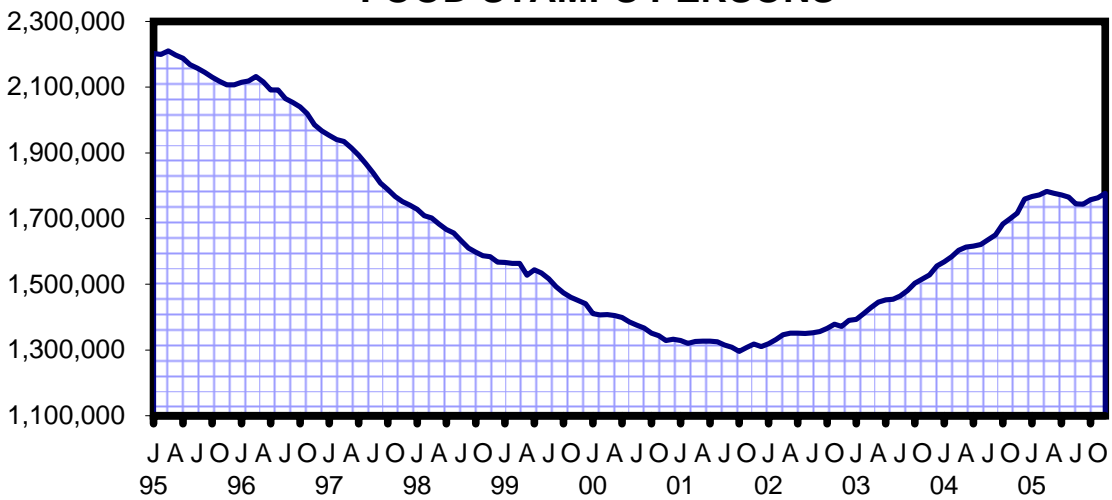

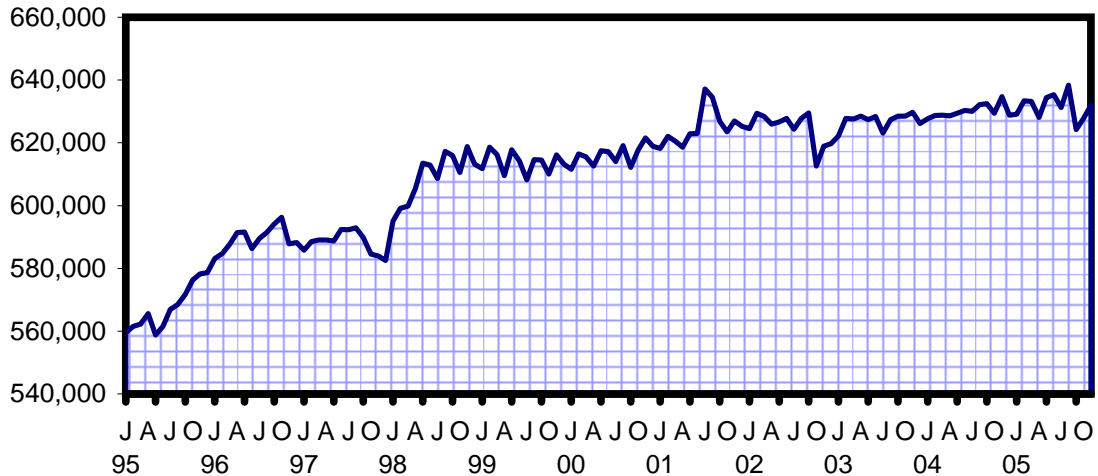
## TEMPORARY ASSISTANCE RECIPIENTS
