JANUARY 2008

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 516,175 in January 2008, decreasing by 123 (-0.0%) from the previous month. Related expenditures totaled \$160,617,153 in January 2008, increasing by \$536,971 (+0.3%) over December 2007.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,932,022 in January 2008, increasing by 82,171 (+4.4%) over December 2007. Food Stamps expenditures totaled \$211,511,522 in January 2008, increasing by \$743,119 (+0.4%) over the previous month.

Note that a substantial portion, but not all, of this increase is the result of a more complete reporting of New York City Food Stamp issuances begun this month, namely the inclusion of some previously excluded expedited, single issuance and Residential Treatment Center cases. See Table 16 for details.

Supplemental Security Income

Supplemental Security Income: For January 2008, SSI recipients (including Mental Hygiene) totaled 650,553 increasing 512 (+0.1%) from the previous month. SSI expenditures in January totaled \$348,183,058 increasing by approximately \$8.0 million (+2.3%) from December 2007.

SSI Table 17 has been revised (February 06, 2009).

Note: Food Stamp data in this report has been revised since its original publication to reflect retroactive adjustments to New York City, and thus statewide, figures that resulted from the reporting changes noted above. New York City monthly average aggregate claims data on Table 23 has also been changed from the original.

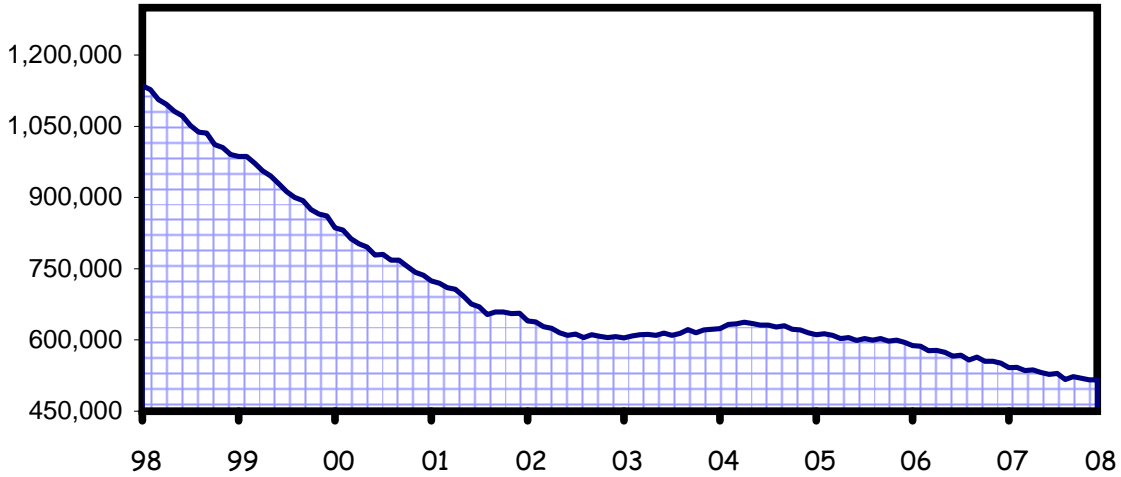

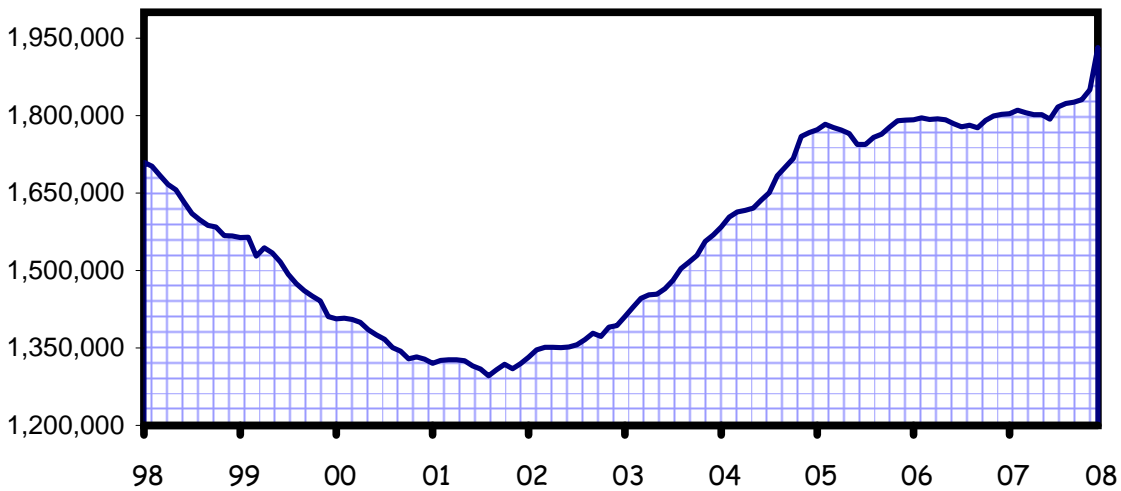

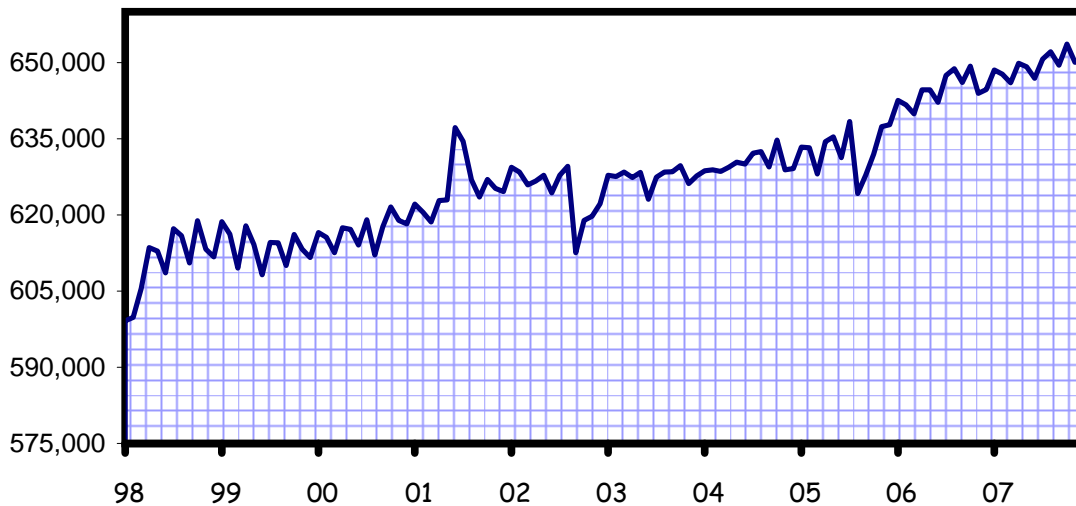
