Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 576,355 in July 2013, decreasing by 3,754 (-0.6%) from the previous month. Related expenditures totaled \$186,424,822 in July 2013, increasing by approximately \$1.4 million (+0.8%) over June 2013.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,194,470 in July 2013, increasing by 7,682 (+0.2%) from the previous month. Related expenditures totaled \$466,485,166 in July 2013, increasing by approximately \$1.02 million (+0.2%) over June 2013.

Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 699,285 in July 2013, increasing by 9,394 (+1.4%) from the previous month. Related expenditures totaled \$409,226,294 in July 2013, increasing by approximately \$9.4 million (+2.4%) over June 2013.

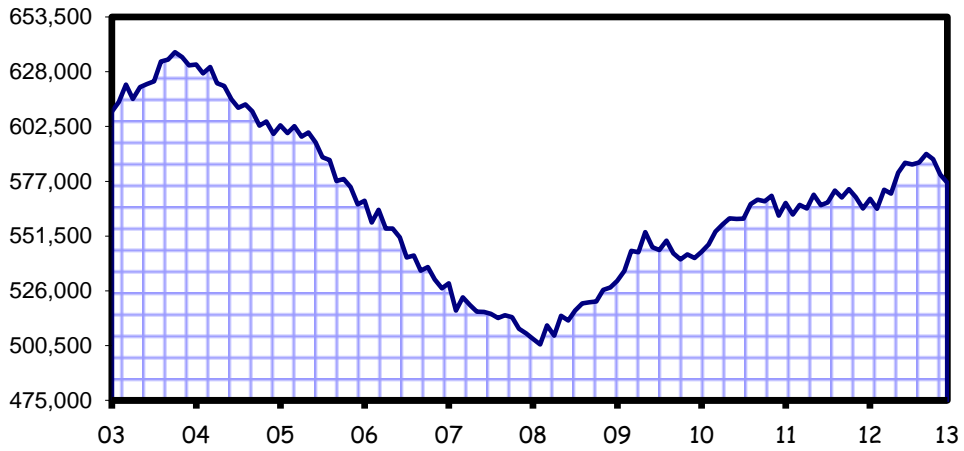

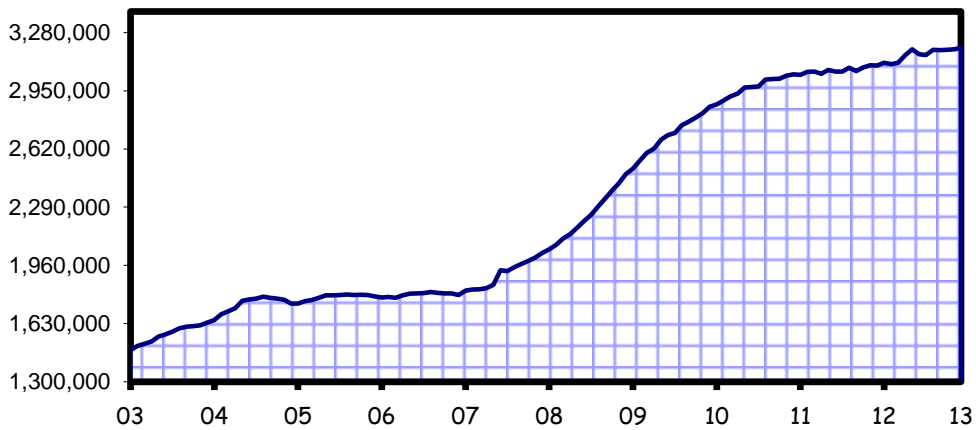

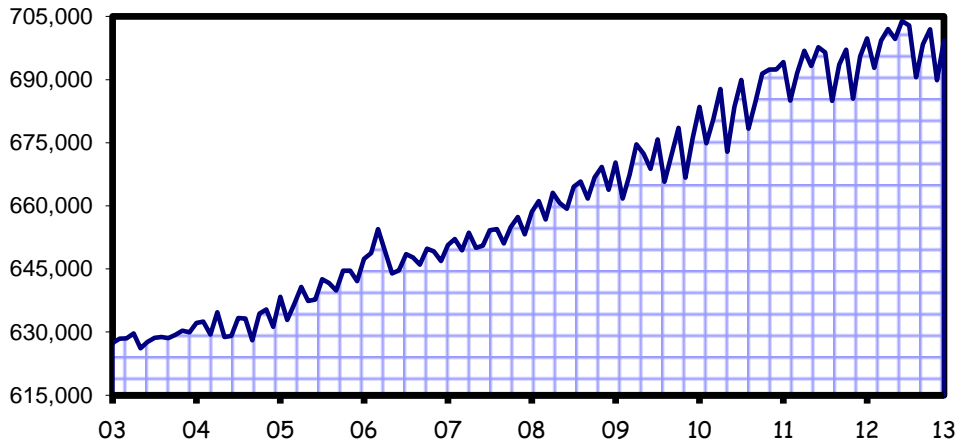
