#### I. PURPOSE

The purpose of this Administrative Directive is to advise local districts of the allocation of closed-ended Title XX Federal funds for the Federal Fiscal Year 1989/90.

#### II. BACKGROUND

New York State's share of the total \$2.8 billion Social Services Block Grant (Title XX funds) for FFY 1989/90 is \$198,623,327 after reduction by the sequestration formula under the Omnibus Budget Reconciliation Act of 1989 (OBRA).

### III. PROGRAM IMPLICATIONS

As in the past, two percent of the total New York State allocation has been withheld for training purposes, leaving the amounts listed in the Appendix as the total district allocation.

With the exception of the training allotment, all Federal Title XX funds to be received are allocated to the local social services districts. As was the practice in previous years, the distribution of these current funds is based on the relationship between each district's 88/89 allocation to the total FFY 88/89 allocation.

Thus, for example, Albany County's FFY 89/90 allocation is determined as follows:

- 1. \$198,623,327 2% Training Allocation = \$194,650,860 All Districts' 89/90 Allocation.
- 2. \$2,370,338 (Albany County 88/89 Allocation) = .0122184457 \$193,996,688 (All Districts' 88/89 Allocation)
- 3.  $$194,650,860 \times .01221844457 = $2,378,331$  Albany County Allocation for 89/90.

<u>Note</u>: Local district services training expenditures are claimed as Title XX expenditures.

#### IV. REQUIRED ACTION

The attached amounts represent each district's share of the Federal allocation for services expenditures based on the original allocation and should be used in planning for the delivery of services.

As in prior years, any unused service funds will be reallocated among those districts having expenditures in excess of this close-ended allocation at the end of Federal Year 1989/90.
