I. Purpose

The purpose of this Local Commissioners Memorandum (LCM) is to inform social services districts (districts) of a revision to the <u>LDSS-4314</u> SNAP Benefits Household Composition Desk Guide, (Rev. 3/21).

II. Background

The <u>LDSS-4314</u> is available for workers to use as a resource to aid in determining SNAP household relationships and composition. Use of this form by districts is optional.

III. Program Implications

The <u>LDSS-4314</u> "SNAP Benefits Household Composition Desk Guide" has been revised to reflect the following changes:

- Under "Students" the following two additional SNAP student eligibility criteria were added to the list of criteria for determining SNAP eligibility for a student who is enrolled at least half-time in an institution of higher education:
 - Attend a SUNY/CUNY comprehensive college, technology college, or community college and are enrolled in a qualified career and technical education (CTE) program, or
 - Attend a NYS Educational Opportunity Centers (EOC) and are enrolled in a CTE program, remedial course, basic adult education, literacy, or English as a second language.
