The purpose of this GIS message is to inform social services districts (districts) that the <u>LDSS-4826B</u> "Interview/Verification Guide for the <u>LDSS-4826</u> Supplemental Nutrition Assistance Program (SNAP) Application/Recertification" (Rev. 1/19) has been revised to reflect the change to the SNAP durational sanction periods effective January 15, 2019.

<u>18-ADM-08</u> "Change to the Minimum Durational Sanction Periods for Supplemental Nutrition Assistance Program (SNAP) Employment Sanctions" informed districts of a change to the minimum durational sanction periods for SNAP employment sanctions. The information on page 6 of the LDSS-4826B related to the minimum sanction periods for SNAP durational employment sanctions has been revised to reflect "1 month and until compliance" for the 1<sup>st</sup> instance of noncompliance with work requirements, and "3 months and until compliance" for the 2<sup>nd</sup> instance of noncompliance with work requirements.
