# Instructions for Biennial Accounting Report Inclusion of Work Experience Program (WEP) Credit Information

The Biennial Accounting Report (BAR) has been modified to include Work Experience Program (WEP) credit information. WEP credit information is displayed by the Month/Year for each "Case Number" associated with the "Lien No". Highlighted in Figure 1 below are the report changes.

## **Biennial Accounting Report: WEP Credit Report Section**

FIELD NAME	DESCRIPTION
MONTH/ YEAR	The Month/Year of WEP participation
DISTRICT	District
CASE NO	Case number
TA WEP HOURS	Hours participated in WEP for Temporary Assistance (TA)
SNAP WEP HOURS	Hours participated in WEP for Supplemental Nutrition Assistance Program (SNAP)
MINIMUM WAGE	The minimum wage for the given Month/Year and District
TOTAL WEP CREDIT	Total TA and SNAP WEP hours multiplied by the minimum wage for the given Month/Year and District
TA WEP CREDIT	Total amount of monthly TA WEP credit that is available to be used to reduce the monthly recoverable TA for this case number. TA WEP credit amount cannot exceed the total amount of recoverable TA payments for the given Month/Year
SNAP WEP CREDIT	Total amount of SNAP WEP credit that is associated with the SNAP benefits for the given Month/Year
TA WEP USED	Amount of TA WEP credit that has been used for a previous recovery for this case number, for the given Month/Year
TA WEP USED BY	Method by which TA WEP credit has been used for this case number, for the given Month/Year. Values can be LOTRY (Lottery), PERIN (Personal Injury Award), LIEN (Real Property Lien/Mortgage), WINDFL (Inheritance), MULTI (Multiple). When multiple WEP credits are used and recorded in the given Month/Year, this field will display MULTI.
TA WEP AVAILABLE	Amount of TA WEP credit that is currently available for this case number, for the given Month/Year

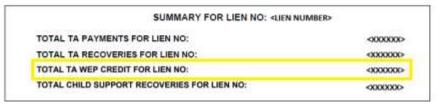
