Section 2

The purpose of this General Information System (GIS) message is to notify social services districts (districts) of the creation and payment of Rest of State (ROS) 2023-2024 Home Energy Assistance Program (HEAP) vouchers.

The initial 2023-2024 Office of the State Comptroller (OSC) HEAP voucher creation dates for ROS payments authorized through the application process (Non-Autopay), and via the Temporary Assistance (TA) and Supplemental Nutrition Assistance Program (SNAP) Autopay are as follows:

- Non-Autopay vouchers: Sunday, October 01, 2023
- TA and SNAP Autopay vouchers: Sunday, October 8, 2023

Once the vouchers are created, the vendor payments are available to districts for review until the payment file is sent to OSC as outlined below. During the HEAP OSC voucher review period, there are only two actions that districts may perform on a HEAP voucher that is in OSC "Issued" status: correction of the customer account number and voiding the voucher.

Please note that each payment line has a unique voucher number, and districts can void HEAP OSC vouchers using Accounts Menu, Selection 4 – Void a Voucher. Districts must not adjust payment lines to zero on OSC vouchers.

All vouchers for vendor direct payments will remain in OSC "Issued" status until they are transferred to OSC for payment, which will begin on the weekend of November 05, 2023. After payments are transferred, their status will update to OSC "Sent."

The initial payment file will contain:

- All HEAP vendor payments not equal to \$476, including Autopay and application authorized payments
- Payments to utility, deliverable fuel (oil, kerosene, propane, coal, wood, wood products), Heating Equipment Repair and Replacement (HERR), and Heating Equipment Clean and Tune (C&T) vendors

After the initial payment file transfer, payment files will be sent to OSC on a weekly basis. The files will contain all HEAP vendor payments, regardless of the amount. Due to the large volume of the transfers, it may take several days to issue these payments.

On September 29, 2023, the HEAP Benefit Issuance and Controls (BICS) locks will be set to "ON" to prevent the issuance of local payments. These locks should remain set as "ON" until OTDA directs otherwise.
