Section 2

The purpose of this General Information System (GIS) message is to inform social services districts (districts) of a revision to the Home Energy Assistance Program (HEAP) Notice of Eligibility Decision – Denial (LDSS-3494B) and Client Notification System (CNS) Denial code W74 – HEAP Heating Equipment Repair and Replacement (HERR) Denial - Resources.

LDSS Form Update

The Notice of Eligibility Decision – Denial (LDSS-3494B) (Attachment 1), also known as the HEAP Manual Denial Notice, has been updated to reflect the updated HERR liquid resource limit of \$10,000. The form has a new revision date of 10/23 and is available in English on LDSS E-Forms for downloading by local districts for local reproduction. Translated and Intelligent Auto Fill (IAF) versions are currently being processed.

Districts must use the 10/23 version of the LDSS-3594B for manual HERR excess resource denials if issuing a HEAP Manual Denial Notice. Districts may continue to use ordered stock of the 7/23 version of the LDSS-3594B for all other manual denials until local stock is depleted. The 10/23 version is in production and not currently available for ordering.

CNS System Update

CNS code W74 – HEAP HERR Denial - Resources is currently not populating the correct liquid resource limit. A correction to the system is in process and is scheduled to be completed by 10/21/2023. Districts are advised to issue a manual denial notice using the LDSS-3594B (revised 10/23) for any HERR excess resource denials until the system update is complete. Districts will be notified when this update is complete.
