Temporary and Disability Assistance Statistics

NOVEMBER 2008

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 505,099 in November 2008, decreasing by 4,824 (-1.0%) from the previous month. Related expenditures totaled \$149,912,340 in November 2008, decreasing by approximately \$10.0 million (-6.3%) over October 2008.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,137,106 in November 2008, increasing by 22,885 (+1.1%) over October 2008. Food Stamps expenditures totaled \$274,362,833 in November 2008, decreasing by approximately \$9.6 million (-3.4%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For November 2008, SSI recipients (including Mental Hygiene) totaled 663,100 increasing by 6,299 (+1.0%) from the previous month. SSI expenditures in November 2008, totaled \$353,396,683 increasing by approximately \$4.1 million (+1.2%) from October 2008.

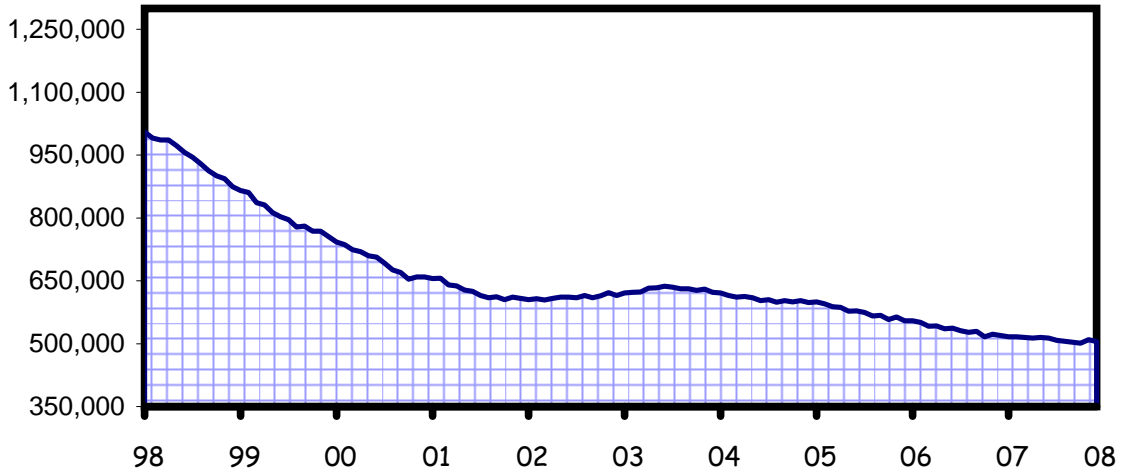

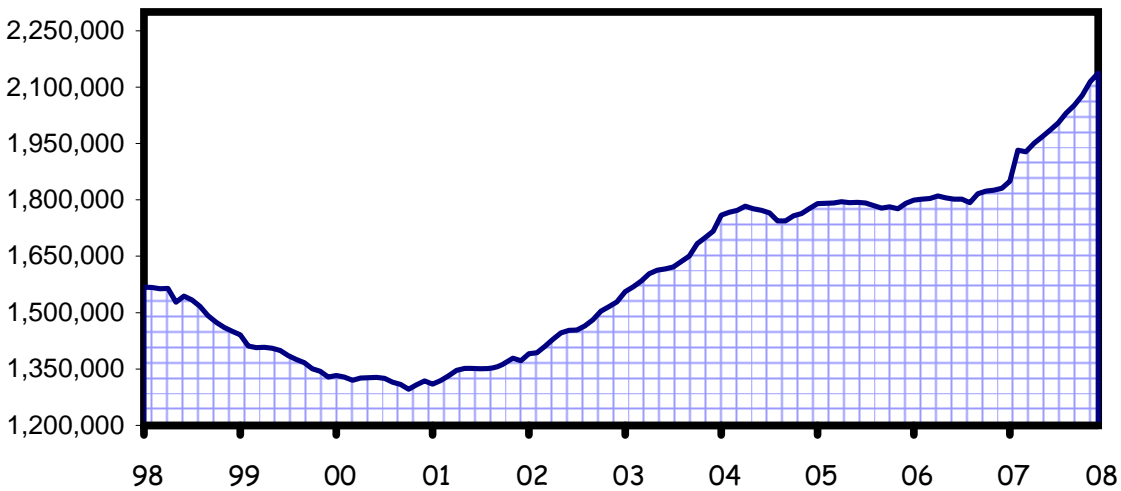

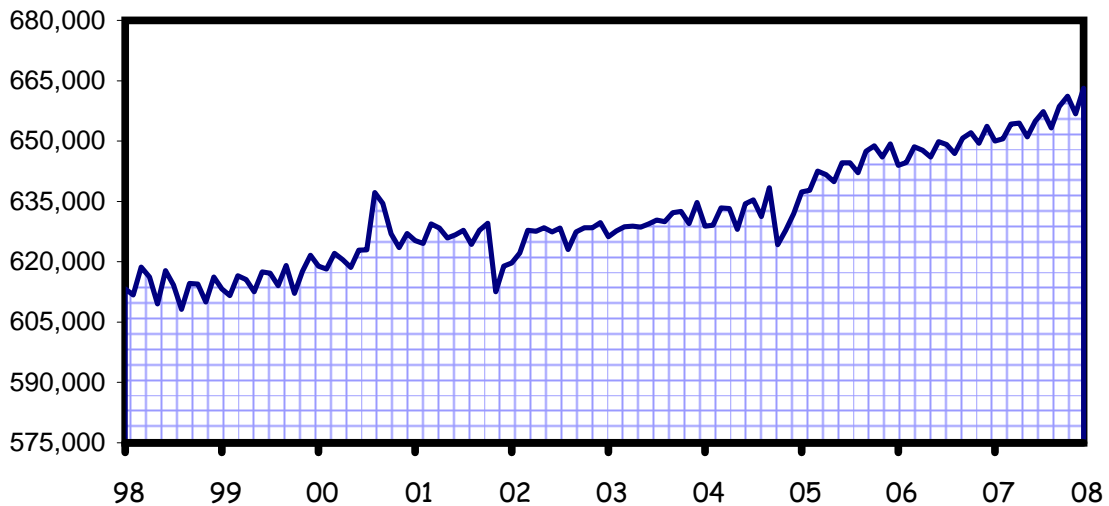
