JUNE 2009

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 526,443 in June 2009, increasing by 5,355 (+1.0%) from the previous month. Related expenditures totaled \$163,996,126 in June 2009, increasing by approximately \$3.3 million (+2.0%) over May 2009.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,427,841 in June 2009, increasing by 43,814 (+1.8 %) over May 2009. Food Stamps expenditures totaled \$372,222,130 in June 2009, increasing by approximately \$5.7 million (+1.6%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For June 2009, SSI recipients (including Mental Hygiene) totaled 669,249 increasing by 2,459 (+0.4%) from the previous month. SSI expenditures in June 2009, totaled \$382,079,552 increasing by approximately \$4.7 million (+1.2%) from May 2009.

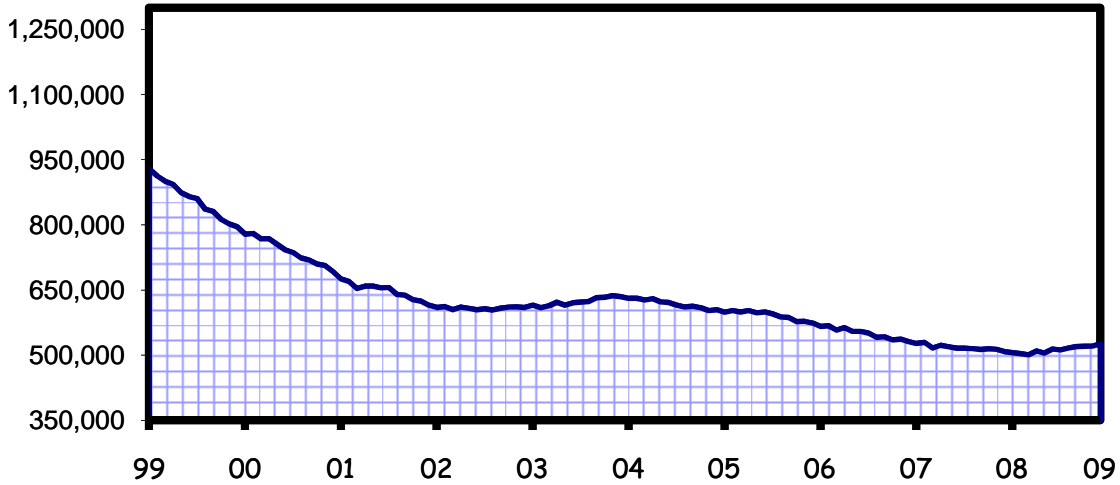

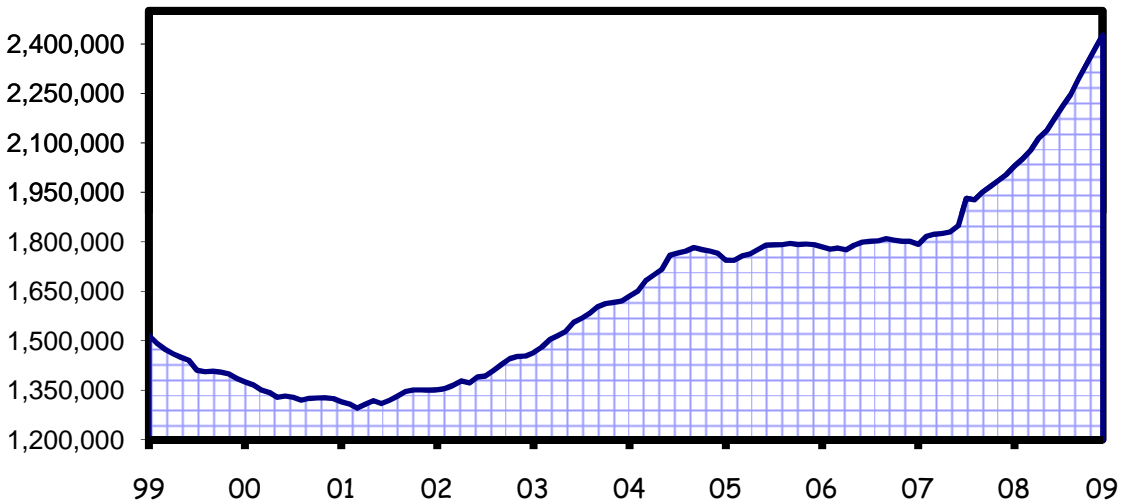

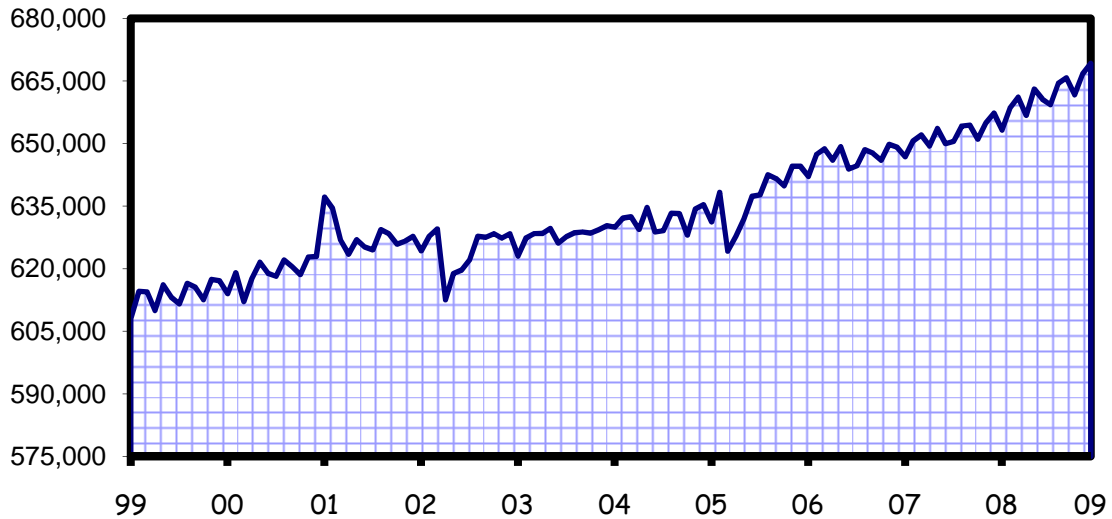
