# Temporary and Disability Assistance Statistics **FEBRUARY 2011**

---

## Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 559,643 in February 2011, increasing by 191 (+0.03%) from the previous month. Related expenditures totaled \$176,130,025 in February 2011, increasing by \$939,457 (+0.5%) over January 2011.

## Food Stamps

Food Stamps: Food Stamps recipients totaled 2,975,444 in February 2011, increasing by 3,568 (+0.1%) over January 2011. Food Stamps expenditures totaled \$447,845,544 in February 2011, increasing by approximately \$1.2 million (+0.3%) over January 2011.

## Supplemental Security Income

Supplemental Security Income: For February 2011, SSI recipients (including Mental Hygiene) totaled 689,954 increasing by 6,440 (+0.9%) from the previous month. SSI expenditures in February 2011 totaled \$393,693,478 increasing by approximately \$11.2 million (+2.9%) over January 2011.

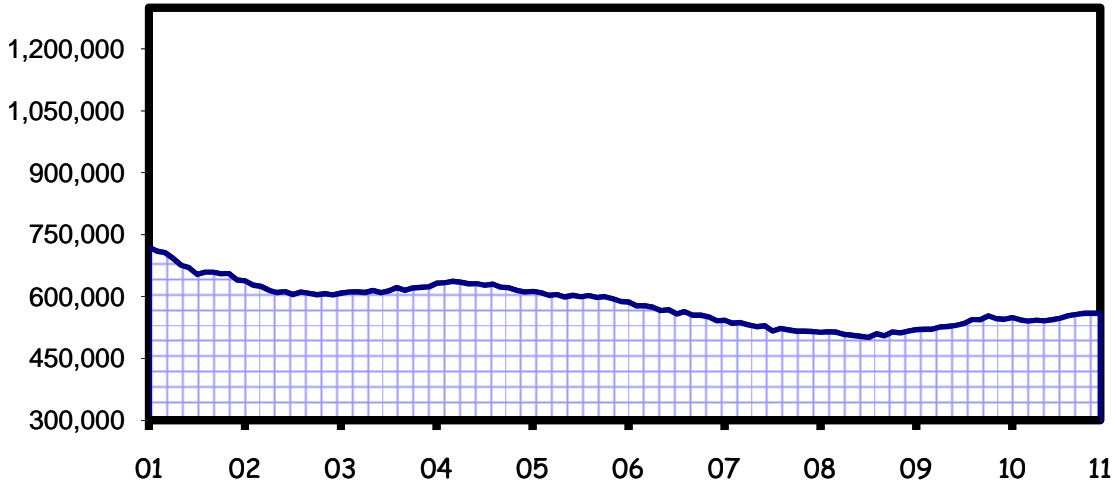

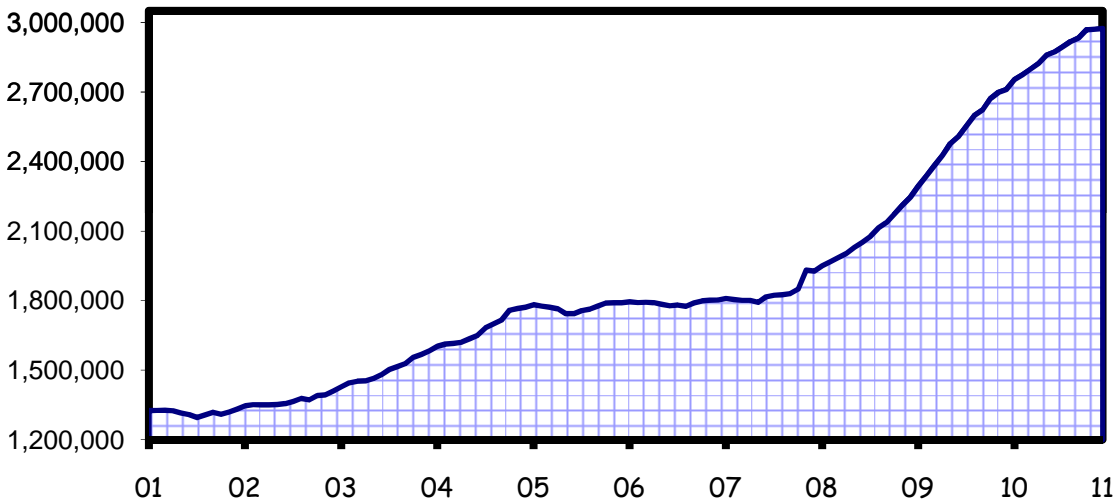

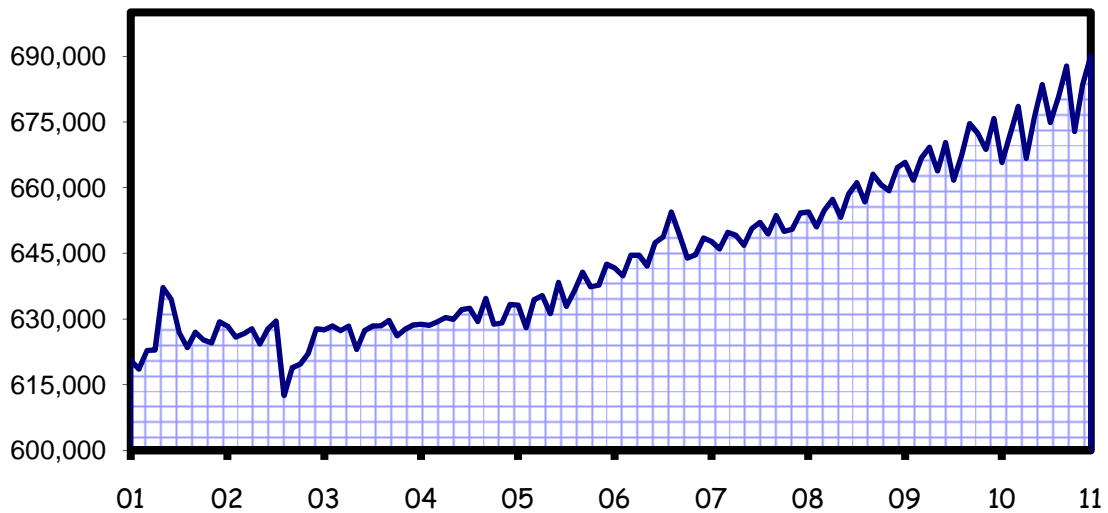
