Temporary and Disability Assistance Statistics **MAY 2012**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 573,363 in May 2012, increasing by 3,817 (+0.7%) from the previous month. Related expenditures totaled \$182,601,494 in May 2012, increasing by approximately \$7.4 million (+4.2%) over April 2012.

Food Stamps

Food Stamps: Food Stamp recipients totaled 3,082,995 in May 2012, increasing by 19,757 (+0.65%) from the previous month. Food Stamp expenditures totaled \$457,609,286 in May 2012, increasing by approximately \$4.95 million (+1.1%) over April 2012.

Supplemental Security Income

Supplemental Security Income: For May 2012, SSI recipients (including Mental Hygiene) totaled 697,134 increasing by 3,500 (+0.5%) from the previous month. SSI expenditures in May 2012 totaled \$403,696,129 increasing by \$833,566 (+0.2%) over April 2012.

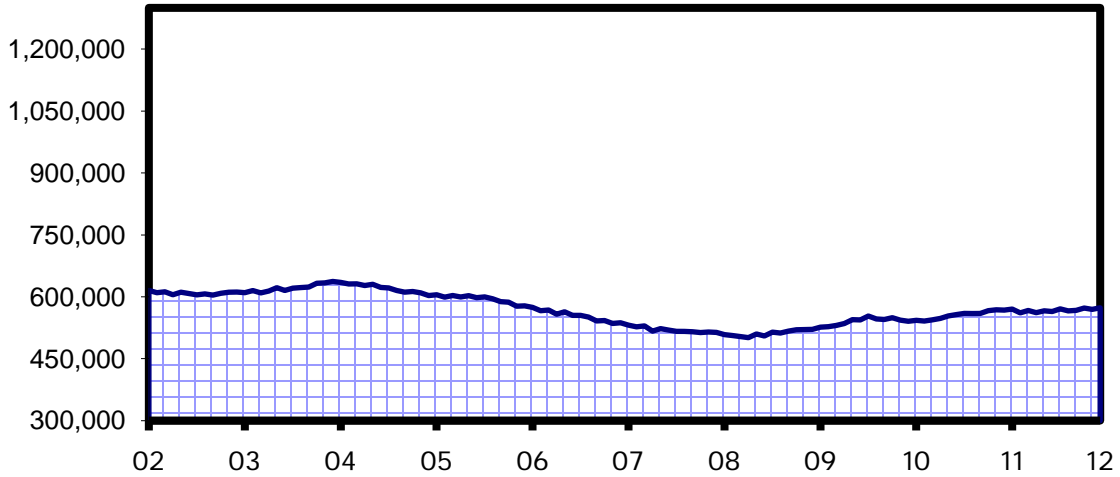

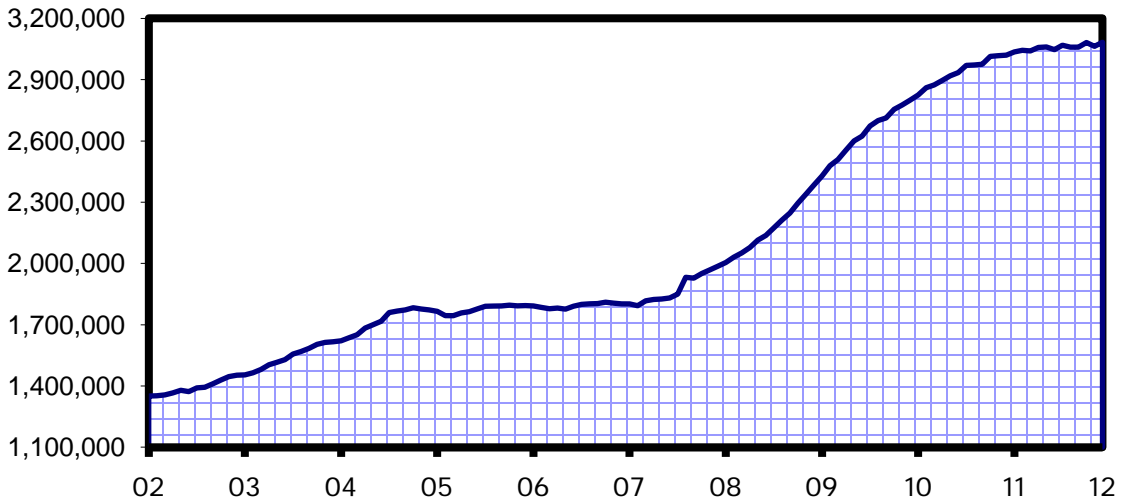

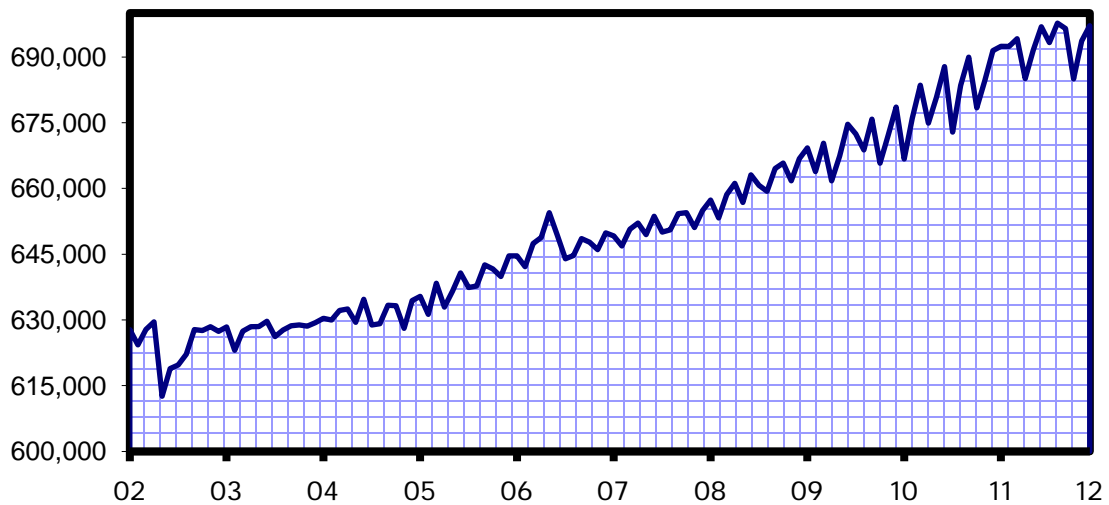
