Temporary and Disability Assistance Statistics

OCTOBER 2012

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 573,068 in October 2012, increasing by 8,867 (+1.6%) from the previous month. Related expenditures totaled \$187,088,842 in October 2012, increasing by approximately \$12.2 million (+7.0%) over September 2012.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,110,070 in October 2012, increasing by 8,880 (+0.3%) from the previous month. Related expenditures totaled \$460,335,257 in October 2012, increasing by approximately \$1.97 million (+0.4%) over September 2012.

Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 699,317 in October 2012, increasing by 6,517 (+0.9%) from the previous month. Related expenditures totaled \$402,818,179 in October 2012, increasing by approximately \$7.19 million (+1.8%) over September 2012.

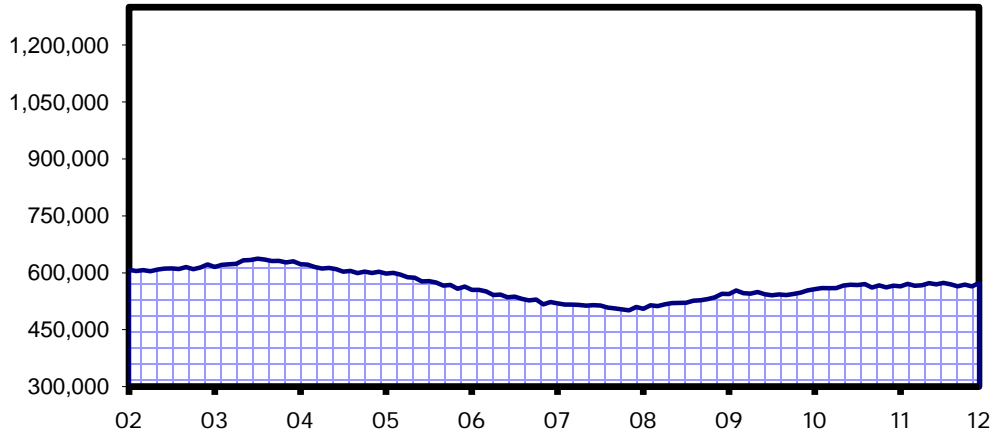

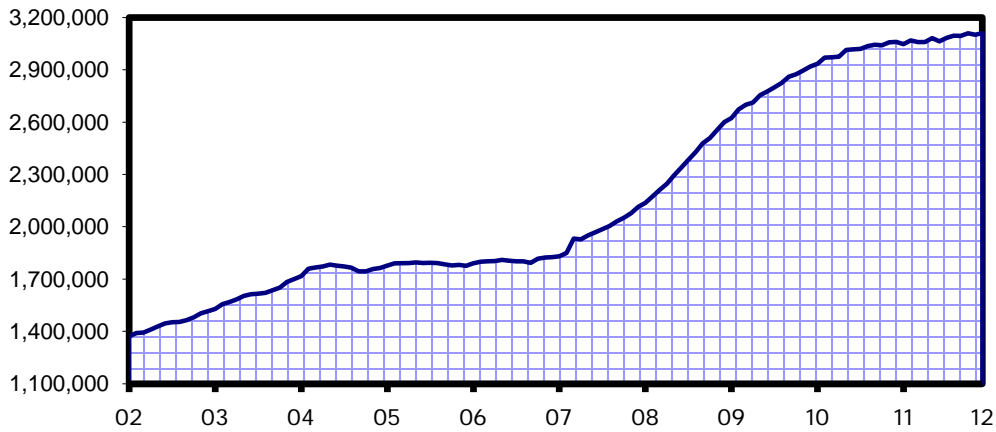

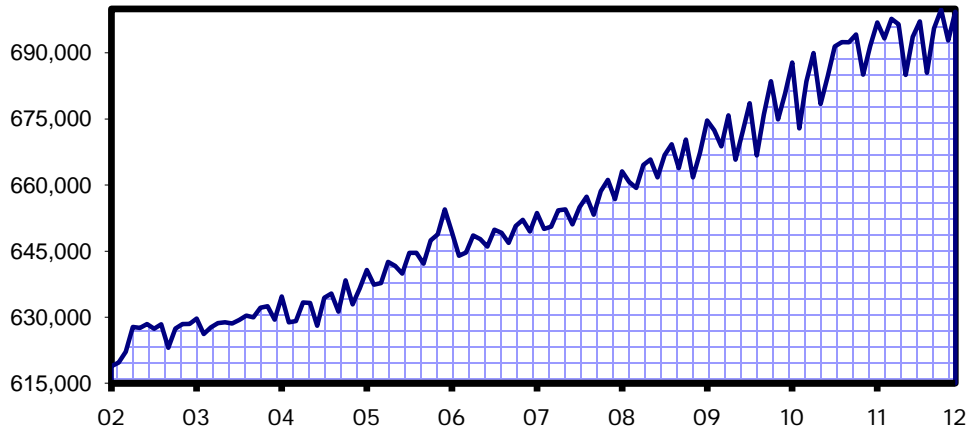
